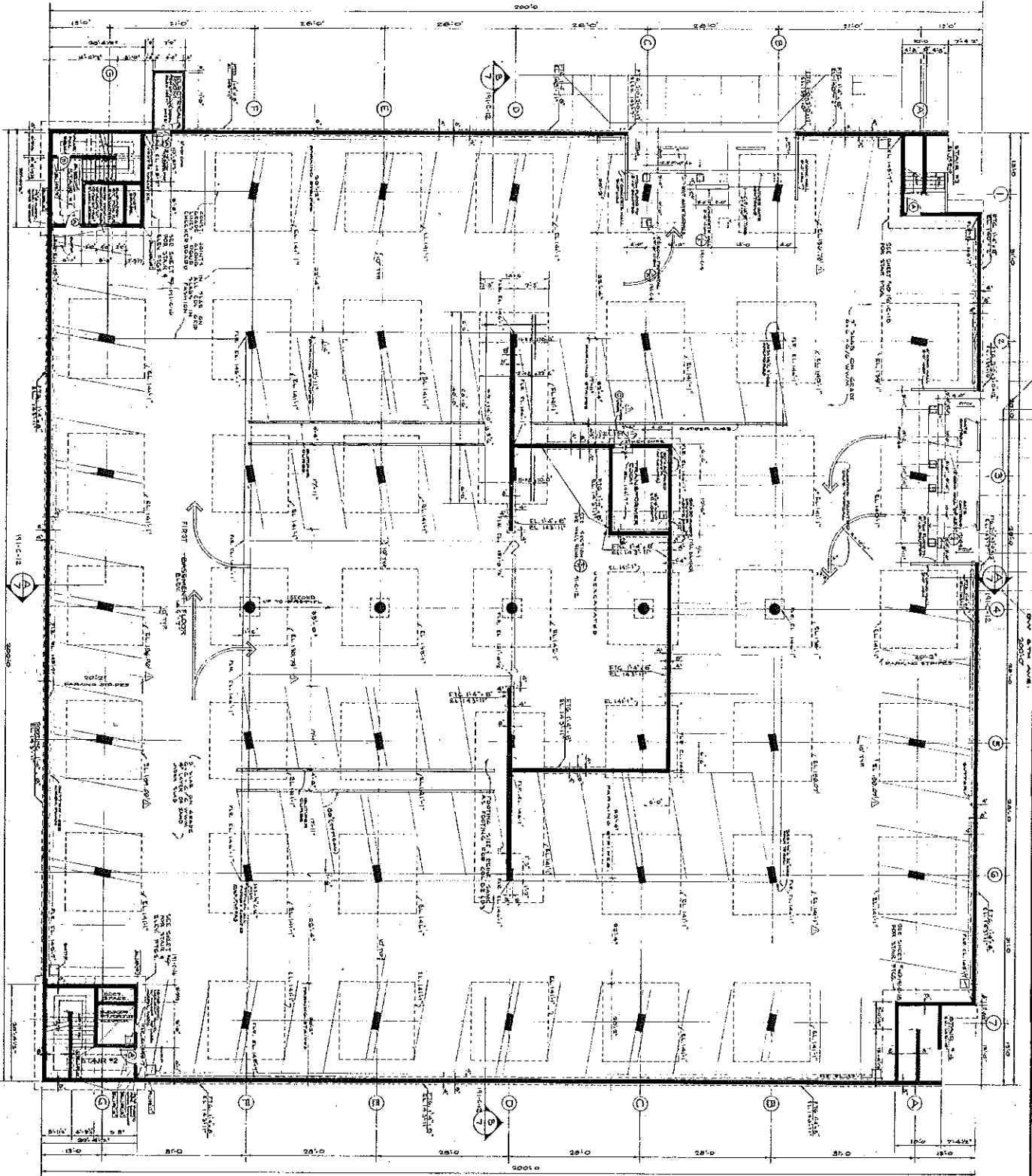
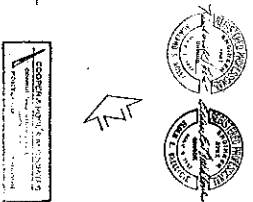
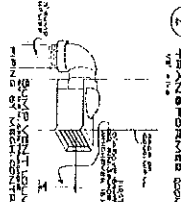


FIG. 1 BASEMENT FLOOR PLAN



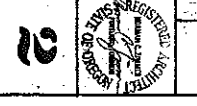

PLAN OF STAIR & GRADE ELECTRICAL



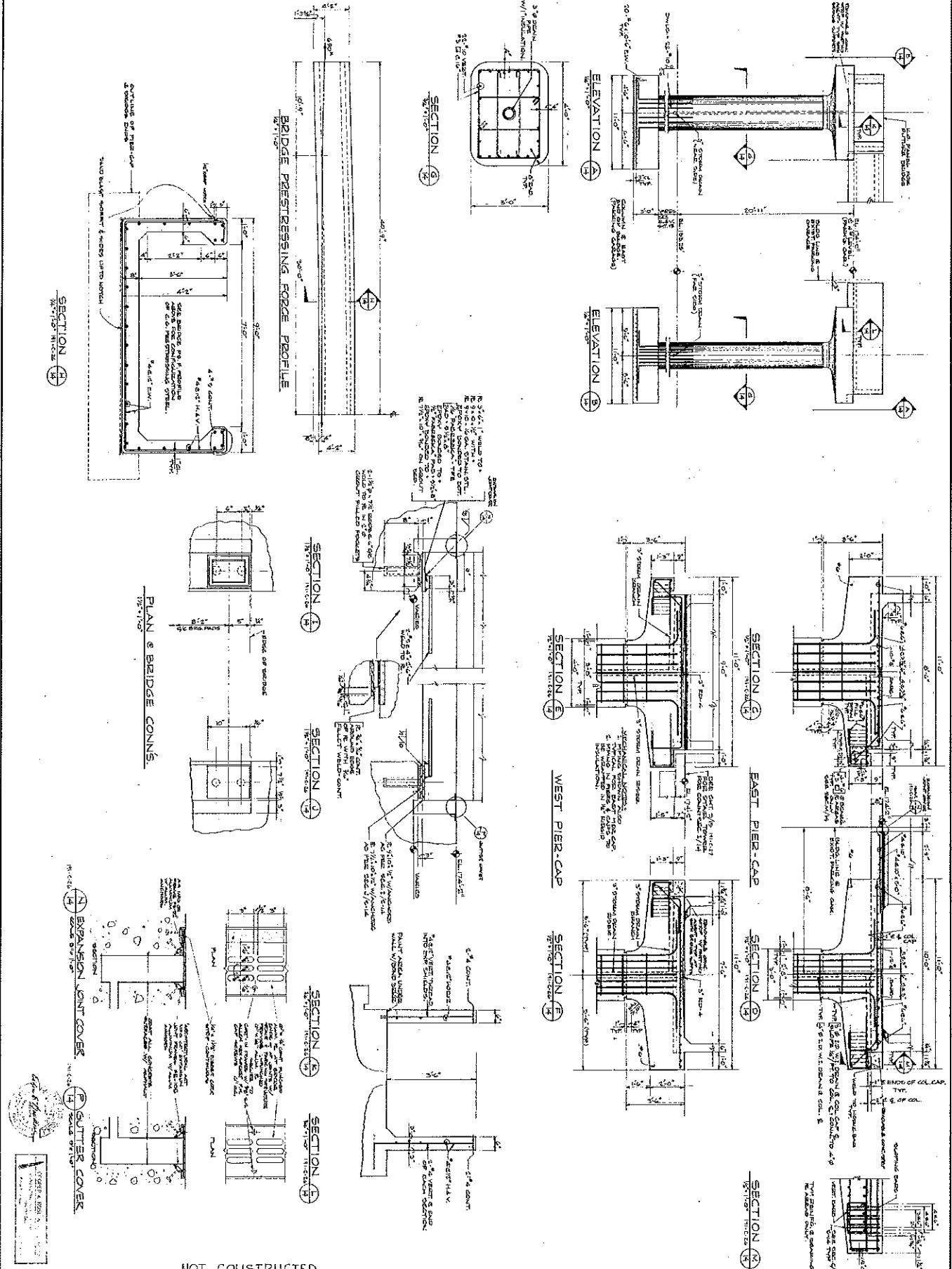
