1.0 BACKGROUND

1.01 OREGON STATE UNIVERSITY:

Founded in 1868, Oregon State University is a comprehensive, research-extensive, public university located in Corvallis. OSU is a member of the Oregon University System and one of only two American universities to hold the Land Grant, Sea Grant, Space Grant and Sun Grant designations. OSU is also the only Oregon institution to hold the Carnegie Foundation's top ranking for research universities, a recognition of the depth and quality of OSU's graduate education and research programs.

Through its centers, institutes, Extension offices and Experiment Stations, OSU has a presence in almost every one of Oregon's 36 counties, including its main campus in Corvallis, the Hatfield Marine Sciences Center in Newport and OSU-Cascades Campus in Bend. OSU offers undergraduate, master's and doctoral degrees through 12 academic colleges enrolling more than 20,000 students from every county in Oregon, every state in the country and more than 90 nations.

1.02 OSU CASCADES:

OSU-Cascades opened in the fall of 2001 to provide access to four-year degree and graduate programs for Central Oregon's burgeoning population and dynamic, expanding economy. A branch campus of Oregon State University (OSU), the Campus distinctively combines the strengths of the state's Land Grant, research-intensive institution with the teaching and research programs. Entering its twelfth year, the campus is growing rapidly and is expanding to become a 4-year University. This growth and expansion necessitates the need for more facilities and the development of a permanent home for the campus. Under the guidance of the OSU-Cascades Expansion Planning Committee, the campus is seeking a qualified Proposer to seek input from stakeholders, research other university campuses and prepare a facilities demand analysis based on academic program and student enrollment schedules to meet the growth plans of the campus.

2.0 STATEMENT OF WORK

2.01 SAMPLE CONTRACT:

3.0 PROPOSER QUALIFICATIONS

3.01 MINIMUM QUALIFICATIONS:

In order to qualify as a Responsive Proposer, the Proposer needs to meet the minimum qualifications below. After verification that the minimum qualifications have been met, OSU will award points based on the level of the Proposer's qualifications.

- a. Previous experience working with institutions of higher education, or other public agencies, in a similar capacity.
- b. Minimum of five (5) years project management experience, including (but not limited to) planning, pricing analysis, move-in remodeling estimating, and growth analysis planning.
- c. Knowledge of applicable laws, rules and regulation of City, County, state and Federal entities relating to the services being provided.
- d. Processes in place that promote working with the client base, analytical research and report presentation, and resources analysis.

3.02 PREFERRED QUALIFICATIONS:

OSU will award additional points for Proposers able to meet the preferred qualifications below.

- a. Previous experience working with institutions of higher education in a similar capacity.
- b. Established presence in, and familiarity with, central Oregon (office location, previous projects, etc...)

4.0 REQUIRED SUBMITTALS & EVALUATION

4.01 REQUIRED SUBMITTALS:

Proposers should submit the following information:

- Description of how the goods or services offered specifically meet the required and preferred specifications described in section 2.
- Detailed information about how the Proposer meets the minimum and preferred qualifications detailed in section 3. At a minimum, the Proposer should provide;
 - Provide an overview briefly summarizing the processes to be used in developing a program analysis and corresponding facilities demand analysis based on academic program and student enrollment schedules.
 - List resources that Proposer brings to this project and those that must be provided by OSU.
 - Provide a complete listing and narrative of projects similar to these RFP requirements that the Proposer has previously conducted, indicating the type of organization, outcomes achieved and how these projects include either direct involvement or familiarity with establishing other infill campuses.
 - Provide samples of materials used for this type of project to include: spreadsheet analysis, related project management documentation, schedules, etc......
 - Describe in detail your approach to involving the OSU-Cascades Expansion Planning Committee, project stakeholders and other University personnel.
- Complete itemized pricing of the goods or services requested. The Proposer's fee structure must include hourly rate for each principle, separate from any related reimbursable expenses. Reimbursable expenses will be paid according to OSU Fiscal Policy Manual (see Exhibit A). The Proposer should clearly delineate fee structure and how fees relate to services performed. The contract will include a "not to exceed cost" statement for the total cost of the contract.
- List of Key Personnel assigned to this project listing the single point of contact.
- Exhibit B, Certifications, fully completed.
 Exhibit C, References, fully completed.

4.02 EVALUATION:

This is a multistage evaluation. OSU will first review all Proposals to determine Responsiveness. Proposals that do not comply with the instructions or are incomplete may be deemed non-Responsive. Proposer's deemed non-Responsive will be notified in Writing, identifying the reason(s) the Proposal is non-Responsive. The evaluation committee will then perform first stage evaluations on the Written Proposals based on the following evaluation criteria. Points will be given in each criteria and a total score will be determined. The maximum points available for each criteria are identified below.

OSU may award after the first stage evaluation to the highest ranked Proposer without moving on to the second stage evaluation. If OSU decides to move to a second stage evaluation, the highest ranked Proposers from the first stage evaluation will move to the second stage evaluation. Proposers who are included in the second stage evaluation may be requested to provide additional information about their Proposal through interviews, presentations, requests for best and final Proposals or other methods relevant to the goods or services, in order for the evaluation committee to make a final determination. Points awarded in the first stage

evaluation will not be carried to the second stage evaluation. Contract will be awarded to the Proposer who in OSU's opinion, best meets the requirements and qualifications of the IRFP and OSU's needs.

4.03 INVESTIGATION OF REFERENCES:

OSU reserves the right to investigate and to consider the references and the past performance of any Proposer with respect to such things as its performance or provision of similar goods or services, compliance with specifications and contractual obligations, and its lawful payment of suppliers, subcontractors, and workers. OSU further reserves the right to consider past performance, historical information and facts, whether gained from the Proposal, Proposer interviews, references, OSU or any other source in the evaluation process. OSU may postpone the award or execution of the Contract after the announcement of the notice of intent to award in order to complete its investigation.

5.0 INSTRUCTIONS TO PROPOSERS

5.01 APPLICABLE STATUTES AND RULES:

This IRFP is subject to the applicable provisions and requirements of the Oregon Revised Statutes, Oregon Administrative Rules, and OSU Policies and Procedures.

5.02 REQUEST FOR CLARIFICATION OR CHANGE:

Request for clarification or change of the Informal Request for Proposal must be in Writing and submitted to PaCS at least two (2) days before the Proposal Due Date and Time, unless specified otherwise herein. Such requests for clarification or change must include the reason for the Proposer's request. OSU will consider all timely requests and, if acceptable to OSU, amend the Informal Request for Proposal by issuing an Addendum. Envelopes, e-mails or faxes containing requests should be clearly marked as a Request for Clarification or Change and include the IRFP Number and Title.

5.03 ADDENDA

Only documents issued as Written Addenda by PaCS serve to change the IRFP in any way. No other direction received by the Proposer, written or verbal, serves to change the IRFP document. If you have received an Informal Request for Proposal you should consult PaCS, prior to Proposal submittal, to assure that you have not missed any Addenda. Proposers are not required to return Addenda with their Proposal. However, Proposers are responsible for obtaining and incorporating any changes made by Addendum into their final Proposal. Failure to do so may, in effect, make the Proposal non-Responsive, which may cause the Proposal to be rejected.

5.04 PREPARATION AND SIGNATURE:

Proposals should be Written and signed in ink by an authorized representative with authority to bind the Proposer. Signature certifies that the Proposer has read, fully understands, and agrees to be bound by the IRFP and all Exhibits and Addenda to the IRFP.

5.05 PUBLIC RECORD:

Upon completion of the Request for Proposal process, information in your Proposal will become subject records under the Oregon Public Records Law. Only those items considered a "trade secret" under ORS 192.50 (2), may be exempt from disclosure. If a Proposal contains what the Proposer considers a "trade secret" the proposer must mark each sheet of information as such. Only bona fide trade secrets may be exempt and only if public interest does not require disclosure.

5.06 PROPOSAL SUBMISSION

Proposals should be submitted no later than the Proposal Due Date and Time. Envelopes, faxes, or e-mails containing Proposals should contain the IRFP No., IRFP Title and the Proposal Due Date and Time. 5.07 PROPOSALS ARE OFFERS:

The Proposal is the Proposer's offer to enter into a Contract pursuant to the terms and conditions specified in the IRFP, its Exhibits, and Addenda. The offer is binding on the Proposer for one hundred twenty (120) days, unless otherwise specified herein. OSU's award of the Contract constitutes acceptance of the offer and binds the Proposer.

5.08 RIGHT TO REJECT:

OSU may reject, in whole or in part, any Proposal not in compliance with the IRFP, Exhibits, and Addenda. OSU may reject all Proposals if it is in the best interest of OSU to do so.

5.09 PROPOSAL PREPARATION COSTS:

OSU is not liable for costs incurred by the Proposer during the IRFP process.

5.10 AWARDS:

OSU reserves the right to make award(s) by individual item, group of items, all or none, or any combination thereof; on a geographical basis and/or on a statewide basis with one (1) or more suppliers. OSU reserves the right to delete any item from the contract when deemed to be in the best interest of OSU.

The Oregon Board of Higher Education, Oregon Secretary of State, Federal Government, and their duly authorized representatives shall have access to the books, documents, papers, and records of Contractor which are directly pertinent to this contract for the purpose of making audit, examination, excerpts, and transcripts. Such books and records shall be maintained by Contractor for three years from the date of contract expiration unless a shorter period is authorized in writing. Contractor is responsible for any audit discrepancies involving deviation from the terms of this contract and for any commitments or expenditures in excess of amounts authorized by Institution.

ASSIGNMENT. Contractor shall not assign or transfer its interest nor delegate its obligation in this contract without the express written consent of the Institution.

AVAILABILITY OF FUNDS. Institution certifies that sufficient funds are available and authorized for expenditure to finance costs of this contract within its current biennial appropriation or expenditure limitation, provided, however, that continuation of the contract, or any extension, after the end of the fiscal period in which it is written, is contingent upon a new appropriation or limitation for each succeeding fiscal period for the purpose of this contract.

CAPTIONS. The captions or headings in this contract are for convenience only and in no way define, limit, or describe the scope or intent of any provisions of this contract.

COMPLIANCE WITH APPLICABLE LAW. Contractor agrees to comply with all federal, state, county, and local laws, ordinances, and regulations applicable to the work to be done under this

STATEMENT OF WORK

There are two phases to the project. In the first phase, the Proposer will be conducting a program analysis for facility needs for an expanding campus. After completion of phase 1, an external real estate agent will present all available properties that meet the needs identified in phase 1. In phase II, the Proposer will evaluate the available properties and make recommendations to the Cascades Expansion Planning Committee.

The successful Proposer will work in collaboration with the Expansion Planning Committee and other University personnel, and will be expected to fulfill the following scope of services including, but not limited to:

Phase I (Requested completion date is October 31, 2012)

- Assist the Cascades Expansion Planning Committee in developing a program analysis and
 corresponding facilities demand analysis to meet the growth needs of OSU-Cascades relocation
 and development, seeking input from stakeholders, researching other university practices and
 preparing a facilities demand analysis based on academic program and student enrollment
 schedules to meet the growth plans of the campus. The analysis will take into account any
 specialized facilities needed by particular academic programs, such as labs.
- Quantify for the appropriate years between 2014-2025 the estimated square footage of buildings needed for classrooms, faculty and administrative offices, and other related student activities such as food service, housing, meeting areas (e.g., student union) and the estimated acres of land to accommodate these and future uses taking into consideration in particular parking requirements. Identify ideal space configurations for classrooms and other specialized university uses, to be used in phase II, as a template for analyzing the appropriateness of existing buildings that may be identified for potential acquisition.

<u>Phase II</u>

- Prepare analysis of Available Properties
 - Define existing-vs-proposed building occupancy and related code issues
 - Identify solution for above issues
 - Identify improvement costs
- Prepare analysis of whether or not needed Improvements can be completed before space is needed to support the growth of OSU-Cascades.
- Prepare a recommendation and associated presentation for property selection
- Prepare related narrative and required supporting documentation for funding requests

Key Personnel; Provide the full name, address, phone number and email address for a single point managerial-level contract for the University who will coordinate all requirements and address all problems/questions that may arise. The key personnel will meet periodically with University personnel and will research information and deliver special reports as needed or directed by the University. It is expected that the successful proposer will be available to attend meetings in Bend, Oregon on the OSU Campus – Cascades.
