The State of Oregon, acting by and through the State Board of Higher Education on behalf of Oregon State University ("Owner") is accepting sealed bids/proposals for a public improvement project at Procurement and Contract Services, Oregon State University, 644 SW 13th Street, Corvallis, Oregon, until 2:00PM local time, October 4, 2012 for the Radiation Center HTTF Equipment Installation project located on the campus of Oregon State University, Corvallis, Oregon. The project includes the assembly and connection of a large-scale piece of Owner-furnished equipment at the Radiation Center on the Oregon State University campus.

A mandatory examination of the site and conditions will be made at 2:00PM local time on Wednesday, September 19, 2012. Bidders shall meet with the Owner's Representative at the Radiation Center, located at 35th and Jefferson Way on the OSU campus. Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

As this is an RFP process, sealed bids will not be opened publicly.

Bids will be received on a lump-sum basis for all of the work. Bid packets may be obtained from Procurement and Contract Services, Oregon State University, 644 SW 13th Street, Corvallis, Oregon (phone number 541-737-9635) only upon deposit of \$75.00. Additional sets may be obtained for a non-refundable purchase price of \$40.00.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security.
