The State of Oregon, acting by and through the State Board of Higher Education on behalf of Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Facilities Services, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:00PM local time, March 19, 2013 for the Callahan Hall Reroof project located on the campus of Oregon State University, Corvallis, Oregon. The project includes the replacement of the roof at the Callahan Hall residence facility on the Oregon State University Campus, Corvallis, Oregon, including but not limited to demolition, fall protection, ladder replacement, roof replacement, sheet metal revisions and sealants.

A mandatory examination of the site and conditions will be made at 10:00AM, March 4, 2013. Bidders shall meet with the Owner's Representative at McNary Dining Hall in the Timberline Room. Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on March 19, 2013 at 2:00PM, local time, at the Oak Creek Building, 3015 Western Blvd., Corvallis, Oregon in Conference Room 103 by the Owner's representative or designee.

Bids will be received on a lump-sum basis for all of the work. Additional sets may be obtained for a non-refundable purchase price of \$40.00.
