GENERAL:

MODIFICATIONS TO SPECIFICATIONS:

- 1. B-5 Bid Form, Modification: Delete original Bid Form and use the Bid Form attached to this Addenda. A new Alternate Bid item has been added (#5, Deletion of window replacement).
- 2. Section 01100 Base Bid and Alternate Bids, 3.02 Alternate Bids, Modification: Add a new Alternate Bid Item as follows:

Alternate Bid Item #5: Delete replacement of exterior windows from scope of Work. Maintain existing interior and exterior aluminum window trim without modification. Delete Sheet A8, Window Replacement Drawings, from Construction Documents.

3. Section 02055 Demolition, 1.02 Extent of Work, Correction: Delete items B and D from Bid Documents.

MODIFICATIONS TO DRAWINGS:

- 1. Drawing 2/A7, CEILING BEAM SUPPORTS, Correction All detail keys with a subscript of A6 shall read A7.
- 2. Drawing 3E/A7, BEAM/POST DETAILS, Clarification Provide 30# building felt separation sheet between wood structure and existing masonry wall surface.

Provide revised partition framing as shown in drawing 2/A9 and revised ceilings per drawing 6/A9. Provide pressure wash cleaning of existing exterior aluminum window trim prior to removal of exterior ADD / DEDUCT: \$____ windows. **ALTERNATE #5:** Delete entire scope of work for exterior windows. Provide a lump sum unit price for each installed 4'x8' replacement sheet of ³/₄" Exposure 1, APA plywood underlayment grade A-C with fully sanded face. ADD: \$_____

4. The work shall be completed within the time stipulated and specified in the Invitation to Bid.

5. The Undersigned certifies that: (1) This Bid has been arrived at independently and is being submitted without collusion with and without any agreement, understanding, or planned common course of action with any other vendor of materials, supplies, equipment or services described in the invitation to bid designed to limit independent bidding or competition; and (2) The contents of the Bid have not been communicated by the Undersigned or its employees or agents to any person not an employee or agent of the Undersigned or its surety on any Bond furnished with the Bid and will not be communicated to such person prior to the official opening of the Bid.
