CALLAHAN HALL RESTROOM & LOUNGE RENOVATION

The State of Oregon, acting by and through the State Board of Higher Education on behalf of Oregon State University ("Owner") is accepting sealed bids and proposals for a public improvement project at Facilities Services, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:00PM local time June 11, 2013 for the Callahan Hall Restroom & Lounge Renovation project located on the campus of Oregon State University, Corvallis, Oregon. The project includes renovation of the existing Men's and Women's gang restrooms on floors 2 through 6 and the creation of a new Student Lounge with Kitchen on the fourth floor located at the existing study lounge and ironing room, as well as other interior and accessibility-related renovations in Callahan Hall.

A mandatory examination of the site and conditions will be made at 11:00AM, May 28, 2013. Bidders shall meet with the Owner's Representative at the North entrance of Callahan Hall, located near the intersection of 15th & Jefferson Way. Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

As this is an RFP process, sealed bids will not be opened publicly.

Bids will be received on a lump-sum basis for all of the work. Bid packets may be obtained from Campus Operations, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon (phone number 541-737-9635) only upon deposit of \$125.00. Additional sets may be obtained for a non-refundable purchase price of \$70.00.
