NOTICE OF PUBLIC IMPROVEMENT CONTRACT OPPORTUNITY

ADVERTISEMENT FOR BIDS

HOGG ANIMAL METABOLISM BARN

The State of Oregon, acting by and through the State Board of Higher Education on behalf of Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Facilities Services, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:00 PM local time August 27, 2013 for the Hogg Animal Metabolism Barn project located on the campus of Oregon State University, Corvallis, Oregon. The project includes the construction of a 13,760 square foot reinforced concrete slab, reinforced CMU block wall barn, and located just North of SW Campus Way and West of 35th Street.

A mandatory examination of the site and conditions will be made at 1:00PM, August 13, 2013. Bidders shall meet with the Owner's Representative at the Oldfield Animal Teaching Facility, located at 35th & Campus Way on the Oregon State University campus. Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on August 27, 2013 at 2:00 PM, local time, at the Oak Creek Building, 3015 SW Western Blvd., Corvallis, Oregon in Conference Room 103 by the Owner's representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid packets may be obtained from Facilities Services, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon (phone number 541-737-9635) only upon deposit of \$150.00. Additional sets may be obtained for a non-refundable purchase price of \$75.00.

Bid packets may be examined at Facilities Services, as well as at the following locations: Daily Journal of Commerce Plan Center, Portland; Eugene Builders Exchange Corporation, Eugene; Salem Contractors Exchange, Salem; McGraw Hill Construction, Portland; Central Oregon Builders Exchange, Bend; Douglas County Plan Center, Roseburg; Willamette Valley Bid Center, Corvallis; Contractor Plan Center, Clackamas, and Reed Construction Data.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security. OUS encourages bids from Minority, Women, and Emerging Small Businesses.
