Warranty Requirements Per Motorcycle				
A submission of a bid in response to this RFQ shall constitute the Contractor's warranty on ALL components, parts and accessories, except for tires, lamps, belts, and batteries for a period of not less than one (1) year. ALL warranties start after the "in-service date." Any portions of the standard warranty on any of the components that exceed these requirements shall apply, including manufacturer's standard warranties on items mentioned herein as excluded. Said warranty shall be honored by all franchised dealers.				
If all or any part of the unit should prove defective in workmanship, design, or materials, the manufacturer or bidder shall replace, revise or repair the part or defect without cost to OSU				
The warranty shall exclude damage to the unit due to accident or misuse.				
In an emergency, if the Contractor is unable to furnish a service representative and parts to the job site within a 48-hour period, OSU may elect to have emergency repairs made and hold the failed parts for the Contractor's inspection, together with sufficient documents to justify or verify the repairs. The Contractor shall reimburse OSU for all costs thereof				
With prior approval and if the unit is urgently needed, OSU may elect to make repairs or have repairs made, and hold the failed parts for the Contractor's inspection, together with sufficient documents to justify or verify the repairs. The Contractor shall reimburse OSU for all costs thereof				
Warranty adjustments will not necessarily be confined to the above limits. Malfunction of parts, or failures discovered beyond the above warranty period which are reasonably attributable to a design or manufacturing defect not revealed during the initial period, shall be corrected at no cost, or on a cost-sharing basis, depending on the individual case
