SECTION 1 - INVITATION TO BID DOCUMENTS

1.1 NOTICE OF PUBLIC IMPROVEMENT CONTRACT OPPORTUNITY

The State Board of Higher Education, acting by and through Portland State University ("Owner") is accepting sealed bids for a public improvement project at the Office of Facilities and Property Management, 617 SW Montgomery Street, Suite 202, Portland, Oregon for the Campus Wide Assessment and Correction of Arc Flash Hazards located on the Portland State University campus, Portland, Oregon ("Project").

The electrical contractor ("Contractor") will be responsible for the following scope of work for construction-related services, including, without limitation:

- Perform a short-circuit analysis of each building voltage system.
- Perform an over-current protection coordination analysis of each building voltage system.
- Perform an arc flash hazard analysis for each building.
- Provide reports for each of the three analyses specified above. For the short-circuit analysis, include both momentary and interrupting reports.
- Perform an evaluation of each panel, providing recommendations to bring the arc flash rating to a Category 2 or better for Personal Protective Equipment (PPE) as designated by the National Fire Protection Association (NFPA) and the National Electrical Code (NEC).
- Provide over-current protection device adjustment suggestions per building.
- Provide any additional work outlined in the specifications provided in Sections 2.3 and 2.4 of this ITR
- "Red-line" any errors discovered on the one-line diagrams while conducting the analyses. (These "red-lines" shall be part of the final close-out documents.)
- Field-verify the type, size and length of conductors.
- Perform any repairs as directed by Owner. Repairs shall be done on a time and materials basis outside the fixed price of the Work above.

Reference Section 2.1 for one-line diagrams for most buildings. All panels needing this work are downstream from the main switchgear in each building. Reference Section 2.2 to determine already completed work.

A mandatory pre-bid conference examination of the site and conditions will be conducted. Attendance will be documented through a sign-in sheet prepared by the OUS representative. Prime bidders who arrive more than 5 minutes after start of time of the meeting (as stated in the solicitation and by the OUS representative's watch) or after the discussion portion of the meeting (whichever comes first) will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud by the Owner's representative or designee.

Bids will be received on a lump-sum basis for the Base Bid work and each Alternate.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" and upon the Bid Form provided. OUS encourages bids from Minority, Women, and Emerging Small Businesses.
