Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Capital Projects Contract Administration, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:30PM local time, December 15, 2015 for the Forest Road Maintenance 2016-2018 project for Oregon State University. The project includes routine maintenance of the Forest road system within the boundaries and jurisdiction of the OSU College Forests McDonald-Dunn, Cameron, Spaulding, Marchel, Rams Dell, Matteson, and Blodgett Tracts located in Benton, Polk, Clackamas, Washington, and Columbia Counties, Oregon

The Owner intends this to be an indefinite quantity Contract for the services and supplies specified effective until March 31, 2019. A minimum quantity of Work shall be guaranteed for the first year of the Contract, with the possibility of additional Work as the need and funding availability arises. The Owner may, at its sole discretion, elect to extend the Contract to include similar maintenance work in successive years, if the Owner is satisfied with the Contractor's Work. A minimum quantity of Work shall be guaranteed for any extension period.

A mandatory examination of the site and conditions will be made at 3:00PM, December 1, 2015. Bidders shall meet with the Owner's Representative at the Research Forest Office at Peavy Arboretum located at 8692 Peavy Arboretum Road, Corvallis, Oregon. Attendance will be documented through a sign-in sheet prepared by the Owner's Authorized Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on December 15, 2015 at 2:30PM, Pacific Time, at the Oak Creek Building, 3015 SW Western Blvd., Corvallis, Oregon in room 103 by the OSU representative or designee.

All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security.
