NOTICE OF PUBLIC IMPROVEMENT CONTRACT OPPORTUNITY

ADVERTISEMENT FOR BIDS

AGRICULTURAL SYSTEMS MANAGEMENT CENTER (ASMC)

The State of Oregon, acting by and through the State Board of Higher Education on behalf of Oregon State University (“Owner”) is accepting sealed bids for a public improvement project at Capital Projects Contract Administration, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:00PM local time, June 10, 2014 for the Agricultural Systems Management Center (ASMC) project located on the campus of Oregon State University, Corvallis, Oregon. The project includes the construction of a 15,000 square foot pre-engineering metal building for the College of Agricultural Sciences, which will contain warehouse space, a farm facilities shop, and additional storage for OSU Network Services.

A mandatory examination of the site and conditions will be made at 1:00PM on May 29, 2014. Bidders shall meet with the Owner’s Representative in Classroom 106 at the Oldfield Animal Teaching Facility, located at 35th & Campus Way. Attendance will be documented through a sign-in sheet prepared by the Owner’s Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner’s Authorized Representative’s watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on June 10, 2014 at 2:00PM, local time, at the Oak Creek Building, 3015 SW Western Blvd., Corvallis, Oregon in Conference Room 103 by the Owner’s representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid packets shall be obtained from Capital Projects Contract Administration, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon (phone number 541-737-9635) only upon deposit of \$150.00. Additional sets may be obtained for a non-refundable purchase price of \$75.00.

Bid packets may be obtained from Capital Projects Contract Administration. Plan & specifications may be examined at the following locations: Daily Journal of Commerce Plan Center, Portland; Eugene Builders Exchange Corporation, Eugene; Salem Contractors Exchange, Salem; McGraw Hill Construction, Portland; Central Oregon Builders Exchange, Bend; Douglas County Plan Center, Roseburg; Willamette Valley Bid Center, Corvallis; Contractor Plan Center, Clackamas, and Reed Construction Data.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security. OUS encourages bids from Minority, Women, and Emerging Small Businesses.
