MEMORIAL UNION ROOFTOP HVAC RETROFIT

Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Construction Contracts Administration, Oregon State University, 644 SW 13th Ave., Corvallis, Oregon, until May 17, 2016 at 2:30 PM Pacific time, for the Memorial Union Rooftop HVAC Retrofit project. The Work Contract consists of basic demolition of selected grease exhaust and makeup air systems serving the Memorial Union. Existing equipment will be replaced with new Makeup Air and Grease Exhaust systems along with new ducting, controls and rooftop screening serving the Commons area. Project location is focused on the west end of the roof of Memorial Union, Oregon State University Campus, Corvallis, Oregon.

A mandatory examination of the site and conditions will be made on May 3, 2016 at 2:00 P.M. Pacific Time. Bidders shall meet with the Owner's Representative at the Memorial Union Commons (food court) on the west end of the Memorial Union on the OSU Corvallis campus. Attendance will be documented through a sign-in sheet prepared by the Owner's Authorized Representative. Prime bidders/proposers who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids are due on May 17, 2016 at 2:30 PM Pacific Time, at Construction Contracts Administration, Oregon State University, 644 SW 13th Ave., Corvallis, Oregon by the Owner's representative or designee. Note: This office is closed Weekdays from 12:00 p.m. to 1:00 p.m.; and entirely on the weekends.

Bids will not be opened publicly.

Bids will be received on a lump sum basis. Bid packets may be downloaded at no charge from the OSU Online Planroom, www.osuplanroom.com . **Hard Copy sets will not be available for purchase.**

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security. OSU encourages bids from Minority, Women, and Emerging Small Businesses.
