The warranty shall exclude damage to the unit due to accident or misuse. In an emergency, if the vendor is unable to furnish a service representative and parts to the job site within a 48-hour period, OSU may elect to have emergency repairs made and hold the failed parts for the vendor's inspection, together with sufficient documents to justify or verify the repairs. The vendor shall reimburse OSU for all costs thereof. Warranty adjustments will not necessarily be confined to the above limits. Malfunction of parts, or failures discovered beyond the above warranty period which are reasonably attributable to a design or manufacturing defect not revealed during the initial period, shall be corrected at no cost, or on a cost-sharing basis, depending on the individual case. The vendor shall not be responsible for damages caused by delay or failure to perform under the terms of the warranty where such delay or failure is due to fire, strikes, acts of God, legal acts of public authority or demands of the Government in time of war or national emergency. The vendor shall be responsible for all warranty adjustment expenses.

Title shall be issued to Team Oregon, OSU for all motorcycles purchased and title costs shall be included in the quoted price. All manuals and catalogs shall be individually assemble and bound. Before the units are accepted a comprehensive inspection will be conducted. Deficiencies found during this inspection must be corrected before the unit can be accepted.
