Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Construction Contract Administration, Oregon State University, 644 SW 13th Ave., Corvallis, Oregon, until Tuesday May 9, 2017 at 2:00 PM local time, for the Parking Lot Slurry Seal 2017 project located on the campus of Oregon State University, Corvallis, Oregon. The Work Contract consists of Removing old built-up parking lot striping, Cleaning, Crack Sealing, Slurry Sealing, New 4-inch paint striping, and New 12-inch paint striping on three different parking lots on OSU's Corvallis campus. The Work will be paid on a Unit Price basis, which will incorporate all Work, including but not limited to mobilization, traffic and pedestrian control, catch basin erosion control on one designated parking lot, and parking lot cleaning prior to applying sealants, as described on the Plans. The Work schedule shall be coordinated with the Owner's Authorized Representative, and shall be planned to minimize parking lot closure for the Work.

A mandatory examination of the site and conditions will be made on Thursday April 27, 2017 at 2:00PM. Bidders shall meet with the Owner's Representative in Oak Creek Building conference room 201, located at 3015 SW Western Blvd. on the OSU campus. Attendance will be documented through a sign-in sheet prepared by the Owner's Authorized Representative. Prime bidders/proposers who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project. Bids will not be opened and publicly.

The Owner intends this to be a unit price contract for the estimated quantities listed on the bid form. Contract will be awarded to the lowest sum of the extended costs. Bid packets, plans and specifications shall be available for viewing and downloading at the OSU Online Planroom website, www.osuplanroom.com.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security. OSU encourages bids from Minority, Women, and Emerging Small Businesses.
