Oregon State University ("OSU") College of Veterinary Medicine seeks vendor quotes for overhead surgery room lighting. The scope of this solicitation is for the provision of medical room lighting, lighting fixtures, and related lighting installation hardware only and does not include installation and related services. OSU desires a lighting assembly comparable or equivalent to the Steris Harmony LED Surgical Lighting (Dual) system. Unit to quote will have four total arms: two arms each containing one light head and two arms for monitor attachment. One of the two light heads must have a High Definition video camera built into the light head. Estimated quantity of purchase is two units; each for mounting in separate operating rooms.

REQUIRED SPECIFICATIONS

In order to qualify as responsive, the quote must demonstrate that the required specifications below are included. Quotes will be rejected as non-responsive if the goods offered do not meet the following required specifications.

- a. 30,000 hour-rated LED life minimum
- b. Minimum two lamp head on separate arms
- c. One lamp head with built in camera "in light" camera
- d. Two additional arms for monitor attachment
- e. Ceiling mountable with continuous rotation of ceiling mount extension arm interface
- f. Continuous rotation of articulating extension arm interface
- g. Continuous rotation of articulating arm at yoke interface
- h. Minimum rotation of yoke at lamp head interface +/- 150 degrees (300 degree range)
- i. Articulating arm minimum range of vertical movement +15 – 65 degrees
- j. Sterilizable surface material on all surfaces
- k. Individual light head, output minimum of 120,000 lux
- l. 4,300 minimum Kelvin color temperature
- m. Single and multiple arm options
- n. Audio Visual Camera included (include camera specifications, zoom, resolution, signal compatibility, etc.)
- o. DVI, HD-SDI, RGBHV, and S-video signal compatible
- p. Near zero radiated heat
- q. Single natural light color emitting LED with no color inconsistencies
- r. LED lighting color rendering ("CRI") index of 97
- s. Shadow reduction technology to maintain focused light on object when obstructed
- t. Electrical input voltage: 100-120 VAC, Single Phase

OPTIONAL SPECIFICATIONS

The following are optional specifications. Optional specifications are not required for award but are options that OSU will accept in addition to the required specifications as part of a vendor quote. The quote must demonstrate that the optional specifications below are available, if provided in the quote.

- a. High Definition surgical grade flat panel monitors (include monitor specifications, dimensions, resolution, etc.)
- b. Adjustable color temperature
- c. Remote lighting controls

- d. Touchscreen wall controls
- e. Adjustable light spot size
- f. Internal wiring protection against kinking and breakage through repeat use
- g. 5-stage dimming capability
- h. Refurbished products are acceptable provided a minimum 90-day warranty is included

CONTRACT AWARD

Contract will be awarded to the lowest quote from a responsive and responsible vendor for lighting that meets the required specifications. If a successful contract or purchase cannot be completed after award, OSU may rescind its award to that vendor and award the next lowest priced responsive and responsible vendor. In the event of a discrepancy between unit prices and extended (arithmetically calculated) prices, unit prices will prevail over extended prices.

QUOTES ARE OFFERS

The quote is the vendor's offer to enter into a contract pursuant to the terms and conditions specified in the RFQ, its exhibits, and addenda. The offer is binding on the vendor for one hundred twenty (120) days. OSU's award of the contract constitutes acceptance of the offer and binds the vendor. The quote must be a complete offer and fully responsive to the RFQ.

OSU is not liable for costs incurred by the vendor during the RFQ process.
