ADVERTISEMENT FOR BIDS

Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Construction Contracts Administration, Oregon State University, 644 SW 13th Ave., Corvallis, Oregon, until Thursday, November 16, 2017, 2:00 PM local time, for the Radiation Center TRIGA Reactor Secondary Cooling Upgrade project located on the campus of Oregon State University, Corvallis, Oregon. The project consists of a complete replacement of primary cooling tower, pumps and heat exchanger serving the OSU Radiation Center. Limited demolition of the existing interior mechanical room along with a new interior room layout with new plate and frame heat exchanger and a new tower and reactor pumps.

A mandatory examination of the site and conditions will be made at 11:00 AM, local time, Wednesday, November 1, 2017. Bidders shall meet with the Owner's Representative at the exterior entrance to the Radiation Center. Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than five (5) minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publically read aloud on Thursday, November 16, 2017 at 2:30 PM, local time, at the Property Services Building, 644 SW 13th Ave., Corvallis, Oregon in Conference Room 110B by the Owner's representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid packets, plans and specifications shall be available for viewing and downloading at the OSU Online Planroom website, www.osuplanroom.com.

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870 as well as the Davis Bacon Act (40USC 3141-3148 and 3146-3148) as supplement by Department of Labor regulations (29 CFR Part 5, "Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction"). All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided. OSU encourages bids from Minority, Women, and Emerging Small Businesses.
