

STREET SWEEPING MAY BE REQUIRED DEPENDING ON THE EXTENT REQUIRED TO LEAVE PARKING LOTS IN A CLEAN CONDITION. CLEANING IS INCIDENTAL TO UNIT PRICES.
- 6. CONTRACTOR SHALL DRIVE EQUIPMENT IN CONSTRUCTION ZONE ONLY AS NECESSARY TO PERFORM WORK, AND TO SIZE IT TO AVOID DAMAGE TO HARDSCAPE.
- 7.
