Item 4 Question: We would like to propose a spindle with

specifications more fit to woodworking in our

quotation:

• Power: ≥ 15 hp

Speed Range: ≥ 0-20,000 RPM
Supply Voltage: 480VAC, 3-phase
Speed Regulation: ±2% (Reversible)

Tool Weight: ≤ 85kg
Sealed spindle bearings
HSK 63 F tool holder

Answer: This is approved.

Item 5 Question: The layout drawing for our AREA 5 axis

machining center is attached. While our machine cabinet fits within the required foot print of 24', we also have a cable track that lays just behind the machine that is an additional 24" in width. We would request

that this cable track be allowed.

Answer: We approve extending the width of machine

footprint A to 26'

Item 6 Question: Our equipment is built and certified to CE

(European) standards. While we will be able to certify the electrical components of the machine to UL, the machine will not hold a UL listing as a whole. We would request that CE certification be allowed, and at a later date SCM will certify the electrical components of

the machine to UL.

Answer: Yes, on the CE certification request. Eventually

the UL listing for the machine has to be

provided to OSU.

V. SELECTION PROCEDURE AND TIMETABLE

A mandatory pre-proposal conference call will be held on June 8, 2018 at 8:00AM. A representative of each proposer's firm is required to attend the mandatory pre-proposal conference call. The conference call number is 1-888-450-5996, the passcode is 518984, followed by the # sign. The conference call will be the proposers' main opportunity to discuss the Project with OSU. Proposals will not be accepted from proposers who have not had a representative attend the mandatory pre-proposal conference call. Attendance will be documented through a sign-in sheet prepared by OSU. Representatives of proposer who arrive more than five (5) minutes after the start time of the meeting (as stated in this solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a proposal to this RFP.

Beginning with responses to this RFP, the selection procedure indicated in Section IX, will be used to evaluate the capabilities of interested Contractors to provide construction related services to OSU for the Project. The proposals to this RFP will be evaluated by the selection committee, which will be comprised of representatives from OSU and other university personnel who do not score proposal or rank finalists and may also include members of the design team who will not score proposals or rank finalists.
