NOTICE OF OPPORTUNITY

ADVERTISEMENT FOR BIDS

Oregon State University ("Owner") is accepting sealed bids for a public improvement project at Construction Contracts Administration, Oregon State University, 644 SW 13th Ave., Corvallis, Oregon, until **2:00PM Friday October 19, 2018** local time, for the **Marine & Geology Repository Mobile Shelves** project located in the Oregon State Universities Nypro Building at 4700 SW Research Way, Corvallis, Oregon. The project includes providing a full anti-tip mobile shelving system with a capacity to hold a minimum of two thousand (2,000) HDPE lidded totes with geological samples weighing up to 40 lbs. each. The shelving must fit within an 11'6" x 43' footprint and cannot be taller than 10'6". The entire shelving system must be in used condition and the vendor must be able to provide a minimum 1-year warranty for all parts and labor. Shelving requirements are described further in the technical specifications.

A mandatory examination of the site and conditions will be made at **10:00AM Wednesday October 10, 2018**. Bidders shall meet with the Owner's Representative at **Nypro Building located at 4700 SW Research Way Corvallis OR 97333, meet at the lower loading dock which is at the SW corner of the building.** Attendance will be documented through a sign-in sheet prepared by the Owner's Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be due **2:00PM October 19, 2018** local time, at the Property Services Building, 644 SW 13th Ave., Corvallis, Oregon by the Owner's representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid packets, plans and specifications shall be available for viewing and downloading at the OSU Online Planroom website, www.osuplanroom.com .

All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870 as well as the Davis Bacon Act (40 U.S.C. 3141-3144 and 3146-3148) as supplement by the Department of Labor regulations (29 CFR Part 5, " Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction"). All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided. OSU encourages bids from Minority, Women, and Emerging Small Businesses.
