The following changes are hereby made:

MODIFICATIONS:

Item 1 Section 2.0 – Second Paragraph – Last sentence is revised to read "Commissioning services will also include testing, adjusting, and balancing ("TAB") services necessitating the payment of BOLI prevailing wage rates for those services."

NOTE: Prevailing wage rates for the project will be established at time of either the initial CMGC Early Work or Guaranteed Maximum Price (GMP) Amendment. An irrigation audit will not be required.

Item 2 With regard to references to LEED certification within the Commissioning Agreement Standards included in the original solicitation as Exhibit 1, OSU will utilize its own scoresheet system which shall be provided to the top scoring firm during fee negotiations.
