**NOTICE OF OPPORTUNITY**

**DAIRY CENTER STORAGE TANK**

Oregon State University (“Owner”) is accepting sealed bids for a public improvement project at Capital Projects Contract Administration, Oregon State University, 3015 SW Western Blvd., Corvallis, Oregon, until 2:00 PM local time, September 3, 2014 for the Dairy Center Storage Tank project located on at 4490 NW Harrison St., Corvallis, Oregon. The project includes construction of a 100’ by 16’ tall concrete tank for the storage of liquid waste for the University’s dairy.

A mandatory examination of the site and conditions will be made at 9:00AM on Tuesday, August 20, 2014. Bidders shall meet with the Owner's Representative at the University Dairy located at 4490 NW Harrison Street in Corvallis, Oregon. Attendance will be documented through a sign-in sheet prepared by the Owner’s Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner’s Authorized Representative’s watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on September 3, 2014 at 2:00PM, local time, at the Oak Creek Building, 3015 SW Western Blvd., Corvallis, Oregon in Conference Room 103 by the Owner’s representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid documents may be viewed at [www.osuplanroom.com](http://www.osuplanroom.com). All bidders must comply with requirements of the prevailing wage law in ORS 279C.800 through ORS 279C.870. All bidders must be registered with the Construction Contractor's Board at the time of bid submission. No bid will be considered unless fully completed in the manner provided in the "Instructions to Bidders" upon the Bid Form provided and accompanied by Bid Security. OSU encourages bids from Minority, Women, and Emerging Small Businesses.
