QUESTIONS:

Item 3 **Q:** For the OSU main campus portion of this, how many awards are anticipated for General Construction?

A: The goal of this RFP is to make multiple awards in each construction category. The final determination on the number of contracts awarded will be made during the evaluation process.

Item 4 **Q:** For the OSU portion, can you elect to bid just the main campus, or must you bid the main campus and the regional portion?

A: Yes, you choose to select just the main campus.

Item 5 **Q:** Can you select individual regions if you are bidding the regional program, is it an "all or none" format?

A: Yes, you can select individual regions if you are bidding the regional program. It is not an all or none format.

Item 6 **Q:** When bidding or being invited to a project, what are GC's providing, just management or all sub costs?

A: We are currently in the bidding process. Upon the award of a contract for a project opportunity, as a General Contractor (GC), you will be responsible for pricing the complete scope of work including management and all sub costs using the Construction Task Catalog® unit prices and your responding adjustment factor.

Item 7 Q: Is the GC to price as a lump sum or is the cost reimbursable based on the rates?

A: The cost to complete the scope of work is determined by the unit prices in the Construction Task Catalog®, multiplied by the quantity of the task, multiplied by your adjustment factor. Each line item of is then added up to determine the final cost to complete the scope of work.

Item 8 Q: Are GC's including subcontractor costs in our proposals?

A: All costs including subcontractor costs will be included in the final price proposal.

Item 9 Q: Are GC's required to use subs in the JOC program?

A: The General Contractors usage of sub-contractors is dependent on the scope of work to complete the project. There may be circumstances in which a GC can self-perform the scope of work, which is allowed.

Item 10 **Q:** Are GC's required to submit adjustment factors for all scopes of work?

Q: Is the State of Washington participating in the Omnia Cooperative portion?
A: No.

Q: Is the OSU Reserve program still going to be available for project awards?
A: Yes.

A: Typical project types may include new construction, repairs, renovations, replacement in kind, maintenance, emergency work, time sensitive projects, and alterations.
