8.8 Communication Blackout
All communications, whether written or verbal, regarding any aspect of this Invitation to Bid (ITB) shall be directed exclusively to the Contract Administrator, the Chief Procurement Officer, or another designated representative of Procurement, Contracts and Materials Management (PCMM). Bidders are strictly prohibited from communicating with any other Oregon State University (OSU) employee, agent, or representative concerning the content, evaluation, or process of this ITB at any time during the solicitation process. Any such unauthorized communication constitutes may result in rejection of the Bid as non-responsive at the sole discretion of OSU.
