# 26<sup>TH</sup> & WESTERN INTERSECTION IMPROVEMENTS

The Oregon University System (OUS) is accepting sealed bids for a public improvement project at Procurement and Contract Services, Oregon State University, 644 SW 13<sup>th</sup> Street, Corvallis, Oregon, until 2:00PM local time, May 8, 2012 for the 26<sup>th</sup> & Western Intersection Improvements project located on the campus of Oregon State University, Corvallis, Oregon. The project includes, but is not limited to, entrance monument masonry walls, columns, lighting and related site improvements; undergrounding overhead utilities; construction of traffic signals; and construction of a right turn lane and associated curb realignment, paving, and traffic control.

A mandatory examination of the site and conditions will be made at 9:00AM, April 24, 2012. Bidders shall meet with the Owner's Representative at the Southeast corner of the Reser Stadium Parking Lot near the intersection of 26<sup>th</sup> Street and Western Boulevard. Attendance will be documented through a sign-in sheet prepared by the Owner's Authorized Representative. Prime bidders who arrive more than 5 minutes after start time of the meeting (as stated in the solicitation and by the Owner's Authorized Representative's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud on May 8, 2012 at 2:00PM, local time, at the Property Services Building, 644 SW 13<sup>th</sup> Street, Corvallis, Oregon in the conference room by the OUS representative or designee.

Bids will be received on a lump-sum basis for all of the work. Bid packets may be obtained from Procurement and Contract Services, Oregon State University, 644 SW 13<sup>th</sup> Street, Corvallis, Oregon (phone number 541-737-9635) only upon deposit of \$75.00. Additional sets may be obtained for a non-refundable purchase price of \$40.00.
