The Oregon University System (OUS) is accepting sealed bids for a public improvement project at Procurement and Contract Services, Oregon State University, 644 SW 13<sup>th</sup> Street, Corvallis, Oregon, until 2:00PM local time on June 5, 2012 for the Sackett Hall Exterior Renovations & Fire Protection project located on the campus of Oregon State University, Corvallis, Oregon. Bids will be received on a lump-sum basis for all of the work.
