- 2. Please provide the current CBA agreement
- 3. Please provide the current Pepsi pouring agreement

- 4. Please provide the following financial breakdown:
 - a. Retail sales, by location for the previous full fiscal year
 - i. Please break down by cash (to include credit card) and flex separate
 - b. Catering sales for the previous full fiscal year
 - i. Please break down by charges to the University (JV charges)
 - ii. Cash charges to include credit card to outside clients
 - c. Vending sales for the previous full fiscal year
 - i. Include cash (to include credit card) and flex separate
 - d. How many current vending machines are on campus and what are the locations Answer - 41
 - e. Who currently provides vending services to the campus

Answer – Three Rivers

- f. Residential Sales for the previous full fiscal year
 - i. Breakdown by plan for each term

- 1. Thus in essence the charges for the four terms by plan
- ii. What plans are there to choose from in the Summer
- iii. How many students are on a meal plan by Summer and what is the breakdown by plan

Answer –The daily usage of flex money at each of the locations on campus for the 2011 and 2012 years will be sent via e-mail. The only one we track cash for is Subway, Sodexo tracks the cash/credit for the rest of the locations

5. Please provide the average daily patron count for each of these locations on a full operating week at SOU.

Answer – do not have these numbers in university system.

6. Please provide the full retail pricing list currently used in all locations for all products

Answer - Info is publicly available. Sodexo asks proposers to gather data on own.

a. i.e. commissions, guarantee, dining override on board plans (if any)

8. The current RFP states that the provider will retain all union associates at current pay rates for a minimum of 6 months. Thus if 51% of the current Union associates are retained the provider would enter into discussion with the union and thus it would be recognized. If this is the case how does this in the Universities vision improve the costs to SOU or the vendor?

9. Does SOU currently collect the meal plan monies and allocate to Sodexo or does it take in the monies and give the entire amount to Sodexo in one lump sum at the beginning of each term?

Answer - SOU collects the meal plan money and commuter flex money from students and allocates it out by the week. For additional flex bought on meal plans we do quarterly disbursements. Monthly for the summer plans and St Mary's programs.

10. What is the pro-rated schedule if a student drops the meal plan in the term?

Answer - If the student lives in the halls they must have a meal plan, we allow them to change it up or down during the 1st 10 days and then they can only go up after the 10

days is over. If they withdrawal from school during the 1st 10 days of a term or get an approved change they get the remainder of the plan prorated back.

11. Is the cost charged to the student that is in the RFP the full amount given to Sodexo?

Answer – Yes, as long as they are a student in the halls Sodexo gets all of the meal money.

12. What are the academic service / feeding days per term?

Answer – 75 days per term (fall, winter, spring)

13. Please note when residential operations begin each term after a break

Answer – We close down after lunch the last day before a break and open up for dinner on the night before classes begin.

14. Please provide current operating hours for Summer and the hours for each location

15. Are there any additional costs to the possible vendor that are not outlined in the RFP?

28. What are the annual pest control costs?

29. What are the current annual cost for voice, data and connectivity services?

Answer \$1,174 per month

30. What is the annual cost of parking for the current vendor?

Answer- Parking permit cost for 2011-12 for a Commercial permit, each vehicle:

- (A) Long-term, twelve months: \$164.
- (B) Long-term, six months: \$97.
- (C) Short-term, one month: \$26.
- (D) Short-term, daily: \$9.
