#### 1.1 GENERAL ITEMS

#### 2.1 CHANGES AND CLARIFICATIONS TO THE PROJECT MANUAL

A. Section 07 3113 Asphalt Shingles Add Paragraph 1.05-C to read:

"C. Warranty:

1. The Contractor shall provide a written warranty guaranteeing all roofing and flashing against defects of workmanship and materials for a period of two (2) years from the date of Final Acceptance and shall maintain the re-roofed areas in watertight condition during this period. The warranty shall be delivered to the Owner prior to final acceptance of the Work.

2. The roofing material Manufacturer shall provide a written **thirty (30)** year warranty signed by a corporate officer for an unlimited sum guaranty covering both installation and materials approved by the roofing Manufacturer. The warranty shall include approved substrates and related materials damaged due to failure of the membrane."

#### 3.1 CHANGES AND CLARIFICATIONS TO DRAWINGS


A. Plan A1: Add following General Notes:

"8. Provide two alternating layers of ¾" plywood on the east side of Bowerman between Bowerman building and the track. Contractor shall guarantee protection of the Hayward track surface, therapy (hot) tubs, and trench drain system adjacent to Bowerman, and that no materials or construction debris lay on that track surface material when performing loading or unloading operations into a truck. Contractor will be responsible to repair/restore/replace any damage to these and other adjacent structures due to inadequate protective measures during the work.

9. Contractor shall provide all means and methods necessary to protect the recently applied top slurry coat surface on the parking lot at Bowerman. No significant impact to this surface will be anticipated due to the scope of work, beyond normal wear. Contractor will be responsible to repair/restore/replace any damage to the slurry coating in the Bowerman parking lot area due to inadequate protective measures during the work."




